# Terms and Conditions of Trading for Lynplan Mail Order Re-Upholstery Service

## Product Guarantee

**Lynplan Re-Upholstery and Renovation ordered through our Mail Order Service is Guaranteed for 3 years from purchase for workmanship and materials.**

**Should your purchase fail to give satisfaction during the Guarantee period, contact our sales staff who will ensure that any difficulties receive immediate attention.**

**This Guarantee does not affect your statutory rights**

### The Company undertakes:

- 1.1 That the Re-Upholstery and Renovation work undertaken will conform to the specification set out on the company's price list and literature.  
The materials used (unless supplied by the client) will be appropriate and will conform with the Furniture and Furnishings (Fire) (Safety) regulations 1988 as amended and any appropriate British Standards.
- 1.2 That prices quoted will be inclusive of VAT unless otherwise specified.
- 1.3 To use its best endeavours to meet delivery dates quoted and to inform customers of likely delays.
- 1.4 That if on receipt of the furniture into the works it is found that for some reason not previously apparent that the furniture cannot satisfactorily be Re-Upholstered and Renovated, to notify the Client and return the furniture and all the payments the Client has made.
- 1.5 If any goods and or services cease to be available to the Company after receipt of the Clients' order and appropriate payment, to notify the Client and either refund the Client's payment in full, or agree an order with other materials.
- 1.6 To insure the Client's goods while in transit and while on the Company's premises for their market value or £2000 per item, whichever is the lower.

### The Client Undertakes:

- 2.1 To pay 10% of the price on ordering, 40% on Collection of the furniture and the balance on delivery.
- 2.2 If the rate of VAT changes, to make any payments due at the new rate of VAT.
- 2.3 To ensure easy access free of obstacles and valuable items for the Company's personnel when Collecting and Delivering furniture.
- 2.4 To clean the furniture in accordance with the instructions.

### Limitation of Liability

- 3.1 The Company will not accept liability for loss or damages for any delay in delivery, nor can it accept liability for loss or damages due to cancellation of the order under clauses 1.5 and 1.6.
- 3.2 Liability for negligent workmanship or faulty materials shall be limited to the order value.

### General Conditions

- 4.1 These general conditions and the conditions above shall form the whole of the contract and supersede any previous contract or verbal representations made by the Company, its employees or agents.
- 4.2 Prices will only be binding on the Company once they have been given in writing by the Company and accepted by the Client.
- 4.3 The Company reserves the right to change prices and specifications in its literature.
- 4.4 No variation of these terms and conditions will be valid unless in writing and signed by a Director of the Company.

### NOTES

- N1 Fabrics always vary slightly in shade from batch to batch. If a precise shade is critical, please ask for a stock cutting when ordering, otherwise it can be assumed the samples give a fair representation of shade.
- N2 These terms and conditions for the Lynplan Mail Order Re-Upholstery & Renovation Service are different to those for Orders placed through our Homecall (individual quotation) service and Tailored Cover Service.
- N3 **If you require two or more pieces of furniture to match, they must be Upholstered/Renovated at the same time.**
